**ARTICLE IX

The corporation's office may be changed at any time by the Board of Directors without amendment of these Articles of Incorporation.

**ARTICLE X  
DISTRIBUTIONS**

No part of the donations of the corporation shall inure to the benefit of or be distributed to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to make distributions in furtherance of the purpose set forth in Article III hereof. Further, the corporation is not organized for profit or organized to engage in any activity ordinarily carried on for profit.

**ARTICLE XI  
DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed to one or more exempt purposes within the meaning of Section 501(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or to a local government, for a public purpose. In the case of Donna M Seager Memorial Scholarship, after all financial obligations are paid, then all assets are to be liquidated and the funds are to be put in a general fund and distributed accordingly to one entity namely North Sanpete High School, Counselor in charge of scholarships, Mt. Pleasant, Utah.
